**MOTION OF DEFENDANT ANÍBAL ACEVEDO VILÁ
TO RESCHEDULE THE APRIL 11, 2008 STATUS CONFERENCE**

TO THE HONORABLE COURT:

Comes now defendant Aníbal Acevedo Vilá through his undersigned legal representation and respectfully moves and prays:

1. Defendant Aníbal Acevedo Vilá, by and through his counsel, hereby respectfully submits this motion to reschedule the status conference currently set for April 11, 2008 at 9:00 a.m. Lead counsel for Governor Acevedo Vilá, Thomas C. Green, will be in United States District Court in Indianapolis, Indiana on April 10, 2008 for a long-scheduled pre-trial conference and *Daubert* hearing in *United States v. Cinergy Corp.*, No. 99-1693 (S.D. Ind.), and will be unable to travel to Puerto Rico by the morning of April 11, 2008. Mr. Green could attend the conference if it were instead held the afternoon of April 11 at 2:00 p.m. or later.

2. Alternatively, Mr. Green is available to attend a status conference the following week. He is available the morning of April 14; or any time on April 16, April 17, or April 18. (Because of a status conference in the United States District Court for the District of Columbia in

United States v. O'Keefe, et al., No. 06-249 (D.D.C.), Mr. Green is unavailable on the afternoon of April 14 and all day on April 15.)

3. Accordingly, Defendant Acevedo Vilá respectfully moves the Court to reschedule the status conference for the afternoon of April 11; the morning of April 14; or any time on April 16, 17 or 18.
