NOTICE OF JOINDER OF MOTIONS

TO THE HONORABLE COURT:

COMES NOW the defendant, **DR. CANDIDO NEGRON-MELLA**, through the undersigned attorney, and most respectfully states, alleges, and prays as follows:

1. The appearing party has been advised that the Court requested that each individual defendant specify in a separate pleading the motions or portions of the motions of the co-defendants that he or she is seeking to join.
2. In compliance with that Order, we hereby inform the Court that Dr. Negrón Mella respectfully requests leave from the Court to join the following motions.
3. Dr. Negrón joins Part I of the *Motion to Dismiss the Indictment* filed by co-defendant Acevedo-Vilá, Dkt. # 182, and by implication all motions requesting dismissal of Count 1 on duplicitous grounds.
4. Dr. Negrón also joins the *Motion to Sever Defendant* and the *Motion To Strike Surplusage*, filed by co-defendant Robert M. Feldman, Dkt. #s 178 and 179, and

by implication all motions requesting severance of the Philadelphia charges and defendants from the rest of the indictment. Dr. Negrón does not join the request for a change of venue.

5. Dr. Negrón also joins the *Motion to Dismiss Count 1 on Grounds of Vagueness*, and the *Motion to Strike Surplusage*, filed by co-defendant Luisa Inclán, Dkt. #s 169 and 170.
6. Dr. Negrón also joins the *Motion to Vacate Trial Setting*, the *Motion for Extension of Time*, and the *Motion Requesting Disclosure of Jury Information* filed by co-defendant Jorge Velasco Mella, Dkt. #s 185, 186, and 187.

WHEREFORE, the appearing party requests that the Court grant the above.
